NOTICE IS GIVEN, pursuant to Section 260, Education Law, State of New York, that petitions nominating candidates for the office of member of the Board of Trustees of the Community Library must be filed with the Clerk of the Board of Education no later than the 30th day (including Saturdays, Sundays, and holidays) preceding the Annual School District Election at which the candidate so nominated shall be elected.

PURSUANT TO Section 2018 of said Education Law, each petition must be directed to the Clerk of the Board of Education; shall be signed by at least twenty-five (25) qualified voters of the District **OR** two percent (2%) of the voters who voted in the 2023 election, whichever is greater; shall state the name and residence of the candidate; shall state the residence of each signer.
